4. Consider review and discussion pertaining to FM 407 construction and possible modifications to Lantana’s connecting roadways and sidewalks;
5. Consider review and approval of proposals for the acquisition and installation of speed control and monitoring devices on Stacey Lane between the Loving Branch Bridge and the entrances to Madison and Juniper Additions;
6. Consider review and acceptance of developer’s report on lot and homes sales and move-ins;
7. Consider review and approval of recommendation from Finance Committee regarding development of recreational projects and venues, and parks and open space projects and special events for Lantana to promote tourism and visitors to Denton County;
